TRUST DEED

RADHA GOVIND SHIKSHA SWASTHAYA TRUST

This deed of Charitable Trust executed on this Monday 19th of August 2013 between Shri Govind Sah, son of Late Rewa Sah, resident of Ramgarh District in Jharkhand, herein after called the Settler (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives) of the one part, and favour trustees under Indian Trust Act 1882.

Radha Govind Shiksha Swasthaya Trust (RGSST)

Definition :

This will be a charitable trust for public work especially for the benefit of entire community having financial crunch by supporting through various mechanism and programmes explained herein to improve their academic, socio – economic and health condition.

Introduction :

The members wish to contribute/donate some money out of their earnings for the welfare of the community. A large number of potential students are unable to continue studies or get employment. Girls remain unmarried due to lack of resources and the community members suffer. Medical facilities are either inadequate or beyond the reach of innumerable persons.

Whereas the Settler is desirous of establishing a trust for public charitable objects.

And whereas the trustees have, at the request of the Settler, agreed to act as first trustees of these presents as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the object and terms of the public charitable trust, being constituted under these presents.

Now this indenture witnesseth as follows:

1. That, in order to effectuate his aforesaid desire, the Settler and the trustees have set apart and handed over to RADHA GOVIND SHIKSHA SWASTHAYA TRUST (RGSST) a sum of Rs. 11,000/- (hereinafter called the trust fund) and the trust shall wholly possess of the same subject to the powers, provisions, agreements and declarations hereinafter contained.

2. The name of the trust shall be **RADHA GOVIND SHIKSHA SWASTHAYA TRUST (RGSST)** and its office shall be located in Ramgarh, Jharkhand. For the present it will be operated from the following address :- **Goushala Road, Vikash Nagar, opposite Railway Station, Ramgarh Cantt, P.S & P.O: Ramgarh Cantt, Dist: Ramgarh Pin- 829122, Jharkhand (India)** and/or at such other place or places as the trustees may decide from time to time.
3. **Area of Operation-** Jharkhand state and other states in India.
4. **That the object for which this trust is established are :**
 - a. To establish, develop, maintain and grant aid in cash or in kind to schools, colleges, professional & technical courses, university, hospitals, health education, nursing institutions, training institutions, dispensaries, maternity homes, child welfare centres and/or such other similar charitable institutions in India for the benefit and use of the general public.
 - b. To grant franchise and to accept franchise in need or to tie-up with any society / trust / organization in different areas where the trust involves actively for the welfare of the society.
 - c. To establish, develop and maintain and grant scholarships for higher studies and aid in cash or kind to suitable recipients & to run, support, grant aid and financial assistance for the welfare activities of community.
 - d. To establish, maintain and run scholarships and render other kind of aid to the students including supply of books, medals and other incentives to study, purely on merit cum poverty basis.
 - e. To establish, maintain and grant aid for establishment & maintenance of park, garden, sports club, rest houses and religious places for the use by the public in general.
 - f. To establish, maintain and grant aid for aged, orphanage or other establishment for relief and help to poor, needy, destitute, widows and aged people.
 - g. To establish and develop mechanism for health care and financial support for physically handicapped, disabled or mentally retarded persons and to provide them education, food, clothing or other helps.
 - h. To support poor families in marriage of their daughters and to promote marriage congress for the community.
 - i. To establish examination centres & study centres Nationally or Internationally.

- j. To encourage fine arts and cultural activities in music, dance & drama and spiritual education.
 - k. To provide hostel facilities to students, trainees, staff, working womens hostel etc.
 - l. To grant aid to render assistance to other public charitable trust or institutions.
5.
 - a. That the trust fund may be augmented by the income from initial fund and also by donations & other contributions of National / International from time to time which is not profitable.
 - b. The trust shall raise funds for the projects and implement the project as per provisions in article 4 above.
 6. That the trust fund shall be applied only for the purposes explained in article 4 above.
 7. That the trustees shall always maintain proper account of the trust fund which shall be kept at the office of the trust.
 8. For fulfillment of the objects of the trust, the trustees shall have the following powers;
 - a. To accept on behalf of the trust any donation, contribution, grant or subscription in cash or kind from any person(s), body of persons, trust or society which may be with or without conditions.
 - b. To use whole or any part of the fund for the object of the trust as per discretion of trustees.
 - c. To invest trust fund for mortgage/shares/stock or debenture or other securities and investments or deposits with or loan to any company, bank, firm, or any other person or transpose such investment at the discretion of the trustees.
 - d. To sell / purchase / lease / rent, construct infrastructure, dispose of, alienate or otherwise deal with any property of the trust fund at the discretion of the trustees.
 - e. To let out trust fund under terms and conditions laid down by the trustees.
 - f. To open account in the name of the trust, trustees and/or institution run/conducted by the trust with a nationalised bank or banks, to operate such account and to give instruction to the bank to provide for opening and operation of such account by one or more of the trustees or by the Chairman appointed by the trustees or in absence of Chairman / authority, the account shall be operated by the representative appointed by the trustees.

- g. To appoint constituted Chairman and to delegate all or any of the power vested to them under these present and from time to time remove such powers of the Chairman and to appoint other or others in his or their places.
 - h. To appoint or make provisions for appointment of any person(s) as administrator or managing trustees or provide appointment of separate trustee / sub-committee for separate fund / functions or to hold any fund or investment as per discretion.
 - i. To make, vary, alter or modify schemes, rules and regulations for carrying out the object of the trust and for the management of the affairs as per discretion.
 - j. To start, abolish, discontinue and restart any charity work and to impose conditions to any subscription or donation as per concern of trustee(s).
 - k. To join, co-operate or amalgamate this trust with others having allied objects.
 - l. To settle account, compromise, compound any action of proceeding without being responsible for any loss incurred by it.
 - m. To borrow money on security of the trust fund/property for the purposes of the objects as in article 4.
 - n. To apply to the govt., public bodies, company, or persons for and to accept grant money and aid, donation, gift, subscription for promoting object of the trust.
 - o. To transfer and handover the trust to any other society, trust or govt. as per conditions / without conditions of the trustees.
9. The trustees shall be accountable for all money coming into their hands, but a trustee shall not be answerable or accountable for neglect, default acts or omissions or commissions of other trustee nor of any banker or other person with whom the trust properties were deposited or kept.
 10. The trustees will not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses incurred by them in connection with the trust or for their duties related to the trust.
 11. The managing trustee / Chairman of the trust will be at the liberty to appoint additional trustees for the time being considered proper.

12. The number of board of trustees shall not be less than 2 or more than 7.
13. The trust will have a Board of Trustees having 2 / 7 members from among the trustees for the effective management of the trust.

The first Board of Trustees will have following members:

14. A person shall cease to be a member of board of trustees either:

- a. If, he / she, without leave of absence, does not attend three consecutive meeting of the board in one calendar year.
- b. If, he / she involves in unauthorized use of funds / wastage of funds or such activities which defames the trust.
- c. If, he / she is requested to resign by 3/4th of the remaining trustees in the board.

15. The tenure of the office bearer will be for a period of three years but can be re-elected on the same post for another term.

16. The Board of Trustees in this deed will be the lifetime Trustees of the Trust. They'll get the salary/honorarium as per their work.

17. Every member of the Board of Trustees will be at liberty to resign on giving one months notice of his/her intentions to do so.

18. The Board of Trustees may, from time to time, frame rules for the conduct and regulation of the meeting of the trustees. In absence of such a regulation:

- a. 2 Trustees shall form a quorum for meeting of Board of trustees.
- b. The trustees will decide all matters mutually.
- c. Resolutions passed in writing by 2/3rd members from Board of Trustees without meeting shall be as valid and effectual as a resolution duly passed at the meeting of the Board of Trustees.

19. In case of doubt in decision, the decisions favoured by majority members of Board of Trustees will be final.
20. Accounting year of the trust shall be financial year ending 31st March of every year.
21. The trust and the trust fund shall be irrevocable for all times.
22. The office of the trust shall be situated in Jharkhand unless changed by 2/3rd majority of the general trustees listed above.
23. It is expressly declared that no part of the trust property or its income or any accretion thereto shall be applied for any purpose, which is not a charitable purpose unblock and all provisions hereof, shall be constructed accordingly.
24. The Settler of the trust will have the powers of a trustee and shall have the right to attend the meeting of Trust and Board of Trustees of the trust.

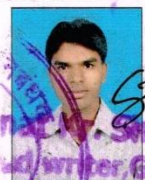
